Lead Action Level Exceedance Notice - Template

DRINKING WATER WARNING

Sampling shows elevated lead levels in some [homes and/or buildings].

<u>Clara Water Association</u> found elevated levels, of lead in drinking water in some homes/buildings. <u>Clara Water Association</u> may also have tested your home or building. If they did, you should receive or may have already received these results. These results are specific to your home/building and may be different from the results taken in other locations. Lead can cause serious health problems, especially for pregnant women and young children. Please read this information closely to see what you can do to reduce leadin your drinking water.

What is an Action Level?

The lead action level is a measure of the effectiveness of the corrosion control treatment in water systems. The action level is not a standard for establishing a safe level of lead in a home. To check if corrosion control is working, EPA requires water systems to test for lead at the tap in certain homes, including those with lead service lines. Systems compare sample results from homes to EPA's action level of 0.015 mg/L (15 ppb). If 10 percent of the samples from these homes have water concentrations that are greater than the action level, then the system must perform actions such as public education, adjusting treatment, and lead service line replacement.

What Happened?

For the first 6 months of the year, we sent out sample bottles to 20 customers to be gathered inside their homes. 3 samples were above the maximum contaminant levels. This does not mean everyone's water is contaminated because we do not know how each sample was collected inside the home.

Between March 4, 2025 and March 6, 2025, we collected 20 samples and analyzed them for lead. The results of more than 10 percent of our samples exceeded the action level for lead.

<u>Clara Water Association</u> is focused on protecting the health of every household in our community; however, lead from service lines and lead plumbing and fixtures can dissolve or break off into water and end up at the

faucet. CLARA WATER DEPARTMENT HAS NO LEAD SERVICE LINES. We found that 3 of our sample homes had over the maximum contaminant level of lead or copper present in the samples given to us. This does not mean that every property that receives drinking water from Clara Water Association has lead in the drinkingwater. It does mean that you should understand how to reduce your exposure to lead through water. Keep inmind that drinking water is not the only potential source of lead exposure, since lead can be found in air, soil, and paint. Health Effects of Lead

Exposure to lead in drinking water can cause serious health effects in all age groups. Infants and children can have decreases in IQ and attention span. Lead exposure can lead to new learning and behavior problems or exacerbate existing learning and behavior problems. The children of women who are exposed to lead before or during pregnancy can have increased risk of these adverse health effects. Adults can have increased risks of heart disease, high blood pressure, kidney, or nervous system problems.

Steps You Can Take to Reduce Your Exposure to Lead in Your Water

Below are recommended actions that you may take, separately or in combination, if you are concerned about lead in your drinking water. The list also includes where you may find more information and is not intended to be a complete list or to imply that all actions equally reduce lead from drinking water.

- Use your filter properly. Using a filter can reduce lead in drinking water. If you use a filter, it should be certified to remove lead. Read any directions provided with the filter to learn how to properly install, maintain, and use your cartridge and when to replace it. Using the cartridge after it has expired can make it less effective at removing lead. Do not run hot water through the filter. - Clean your aerator. Regularly remove and clean your faucet's screen (also known as an aerator).
 Sediment, debris, and lead particles can collect in your aerator. If lead particles are caught in the aerator, lead can get into your water.
- Use cold water. Do not use hot water from the tap for drinking, cooking, or making baby formula as lead
 dissolves more easily into hot water. Boiling water does not remove lead from water.
- Run your water. The more time water has been sitting in your home's pipes, the more lead it may
 contain. Before drinking, flush your home's pipes by running the tap, taking a shower, doing laundry, or
 doing a load of dishes. The amount of time to run the water will depend on whether your home has a
 lead service line or not, as well as the length and diameter of the service line and the amount of
 plumbing in your home. Residents may contact us at <u>Clara Water Department</u> for recommendations

- Learn what your service line material is. Contact us at 601-735-2428 or clarawaterdepartment@gmail.com or a licensed plumber to determine if the pipe that connects your home to the water main (called a serviceline) is made from lead, galvanized, or other materials. Get Your Child Tested to Determine Lead Levels in His or Her Blood

A family doctor or pediatrician can perform a blood test for lead and provide information about the health effects of lead. State, city, or county departments of health can also provide information about how you can have your child's blood tested for lead. The Centers for Disease Control and Prevention (CDC) recommends that public health actions be initiated when the level of lead in a child's blood is 3.5 micrograms per deciliter (µg/dL) or more. What is Being Done?

The actions that we are taking are following [Federal AND/OR State lead and copper regulations] listed below.

In addition to the information mentioned above that we will provide to residents at locations we sampled, we will also be following up with additional public education to all our customers by May 10, 2025.

<u>Clara Water Department</u> balances water chemistry to minimize pipe and plumbing components from corrodingand leading to the possibility of lead dissolving into water. This process is known as corrosion control. We are completing an assessment of the corrosion control treatment currently used by our water system and we are currently installing a new water treatment plant due to be completed by the fall of 2025.

We also plan to take the following steps:

- We are conducting additional lead and/or water quality monitoring of our water system supply.
- We are increasing our lead monitoring to determine the extent of the situation.
- We are currently installing a water treatment plant.
